Without a say in the weather and the wet conditions, we have started out on a very positive note producing a beautiful flock of flourishing lambs. The calving is well on its way and we are working hard to facilitate two main areas on our farm, water and drainage. By assisting these areas, we aim to increase access to more parts of the farm. In the last few months, we have made some necessary purchases such as replacing our 30 year old tractor. We have also purchased an excavator to support the drainage programme, roading on the farm and reducing sediment into our harbour.



Forestry

Our forestry is due to be thinned and we are in the process of forming our thinning operation. By doing this, we hope to entice a diverse group of people and see this as a new opportunity for our community. We will have some experienced workers in thinning, who can share their knowledge to the younger generation - Mike Wikitera, a man experienced in many fields such as training and health and safety will also be a huge asset to this process. Overall the forest thinning is moving positively forward. We are presently in negotiation with Juken New Zealand Limited (JNL) and Mt Pokaka Timber Products Ltd with the thinning and thinning to waste of our trees and steadily working on the operation to see more progress within the near future.



Apiculture



Our Bee Keeper Phyllis Kapa has been doing a fantastic job with our bees and hives. Although the season is wet, the bees are still very active and thriving. Our manuka has started to flower which is a very sure sign that we

are well on our way to successful season. We have planted over 220K manuka trees in the last 12 months. Our goal is to plant another 100K trees every year for the next 3 years. This operation will provide excellent job opportunities for our local community.
