Paua Station currently employs 7 full time staff: Josh Williamson is the Farm Manager, Deane Henare-Toka is the Head Shepherd, Tristan Golley is the Shepherd, Lewis Brown is the Tractor Driver/General Hand, Roy Garea is the Fencer/General Hand, with Tim Everitt and Shane Wright as General Hands.

Te Rangi Station currently employs 6 full time staff: Duanne Golley is the Farm Manager, Johnny Everitt is the Head Shepherd, Simon Abraham is the Shepherd, Ian Smith is the Water Man/General Hand with Murray Larsen and Joshua Nathan as the General Hands.

Cape View Station is a 900+ hectare farm that we lease and currently employs two full time staff: Neil St George is the Farm Manager and Anne Walker is the General Hand.

Grant Kidd is our qualified builder and works with the General Manager and Farm Managers to plan



all the building work that needs to be done on the farms. As you can imagine, there is plenty of work to keep Grant busy.

John has held various roles, his most recent was as General Manager which he has held since September 2006. Last year John resigned from the Incorporation to pursue other interests. Crown Forest

In March of this year the last of our mature trees in the Parengarenga A forest (knowns as the Crown Forest) were felled by Mark Nathan. To mark this day shareholders were invited to attend the felling celebration out in the forest, along with others involved in the planting and management of this forest over its lifetime.

The future of our forests going forward

The stumpage income we receive from both of our forests will come to the end in early 2016. The trees we have planted, after the harvesting of the original trees, require another 10 years to grow before they are viable to be harvested. This income was used for debt reduction, forest management and maintenance amongst other things. Without this income, our farms are being tasked with covering the costs to run the Incorporation for the next 10 years, whilst our trees grow bigger over that time.

Hugh Ford from Hancock Forest Management, that manages our Te Kao Forest, advised that one of three harvesting crews has now finished and have left the block. Another crew will be finishing around the end of June leaving one crew who will stay on until the first rotation is completed either in February or March 2016.

Summit Northern Plantation (SNP)

The Incorporation is entering into a forestry management agreement with SNP to undertake the management of our forestry interests over the next decade. SNP is a reputable forest management company cemented in the Northland region. The Trustees view this agreement as beneficial to the Incorporation.

Reducing costs
