Staffing Update

We are very pleased to advise you that Jon Brough has been appointed as our new General Manager and will start in September.

Farming Update

Last year our two farms merged as one business unit; to be now known as ‘Parengarenga Station’. This has proven to be very successful and are encouraged by the lead our staff has taken.

Over the last month or two we have had plenty of rain. This has made it very wet underfoot and contributed to a shortage of feed. At the moment we are lambing and calving so our staff are being kept very busy.

Our workshop, where we service our own vehicles and undertake repairs and maintenance of equipment, is working very well.



Forestry Update

We are currently in a selection process regarding the Parengarenga ‘A’ forestry management contract. We have had some very interesting presentations from three companies with a wealth of experience in forestry management. In addition to this we have appointed an independent consultant which will give us a set of benchmarks to assist in the analysis of the proposals.

We are hopeful to complete assessment and due diligence by the end of September and complete final negotiations by the end of October, but this timeframe could be affected by a number of factors and may change in either direction.

On Monday 12th September a fire was accidentally started our forest that destroyed 0.2 of a hectare of young trees that were planted recently. Two days later this piece of land was replanted which is very fast indeed. This is a timely reminder for all of us to ensure that we are aware of the dry nature of the Far North, where a fire permit is required all year around, and the damage that can be caused by fire.

Amalgamation Update

We continue to work with a Maori Land Court-appointed person dedicated to produce a process to move forward with our amalgamation which is very encouraging.
