As is typical, at this time of the year, much of the pasture has started to dry out but our team on Parengarenga Station have done an outstanding job in getting good results from both sheep and beef. We have recently entered a new phase in farm development by enlisting the services of Nutri-Link and Seed Force to enhance the pasture development program. This will enable us to better understand the capability for pasture growth across the Station and to maximise our stocking rate.
